

TAW PAINTBALL WAIVER AND RELEASE OF LIABILITY

Please read and complete thoroughly and carefully!

In consideration of **TAW PAINTBALL** furnishing services and /or equipment to enable me to participate in paintball games, I acknowledge and agree as follows:

I fully understand and acknowledge that:

- (a) Risks and dangers exist in my use of paintball equipment and my participation in paintball activities.
- (b) My participation in such activities and/or use of such equipment may result in, but not limited to, bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability.
- (c) These risks and dangers may be caused by the negligence of the owners, employees, officers or agents of **TAW PAINTBALL**. The negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes.
- (d) By my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of **TAW PAINTBALL**, or by any other person.
- (e) I understand that I am playing in these games at my own risk, freely and voluntarily without any inducement.

I, on behalf of myself, my personal representatives, next of kin and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify **TAW PAINTBALL**, the field operator, the event promoter, the owners and lessors of premises used to conduct the paintball event, their owners, agents, officers and employees from **any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise** which may arise out of my use of paintball equipment or my participation in a paintball event. I specifically understand that I am giving up any rights that I may have by releasing, discharging and waiving any claims or actions presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of **TAW PAINTBALL**.

I also grant permission for the use of my name and or likeness related to my participation in any event conducted by TAW PAINTBALL. I also grant permission for the use of my voice and any and all recorded, filmed, video, digital, photographed footage of me and further waive any and all rights to compensation as a result of my name and/or likeness being used.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE THAT IT IS MY INTENTION TO EXEMPT AND RELIEVE **TAW PAINTBALL** FROM ANY AND ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.
